SPECIAL PROVISIONS

SCOPE OF WORK

The scope of this project shall include construction of a 59' long I-beam bridge with a concrete deck and a 36' long I-beam bridge with a concrete deck. The beams will be provided by the County at the sites. The unit price bid shall include all labor and materials, except for the beams, required to complete the bridge in accordance with the enclosed plans and specifications. Plan quantity does not include cut off, lap, or waste. The Contractor shall adjust the price bid for any cut off, lap, or waste.

The contractor shall be responsible for all underground utilities. Call OKIE at 1-800-522-6543 two days prior to beginning construction.

STANDARD SPECIFICATIONS

All work shall be performed in accordance with the "Standard Specifications for Highway Construction", Oklahoma State Highway Commission, 2009 Edition, except as modified herein. The aforementioned specifications are hereby incorporated by reference and shall have full force and effect as though printed herein.

For the purposes of this contract, Beaver County shall be substituted for "Commission" where it appears in the specifications and "the Engineer" shall mean EST, Inc., 615 N. Hudson Ave., Suite 300, Oklahoma City, OK, 73102.
