County Commissioners Proceedings  
January 2, 2018

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on January 2, 2018. Notice of the meeting was posted for public information on December 28, 2017 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse and [www.beaver.okcounties.org](http://www.beaver.okcounties.org).

Regier called the meeting to order at 9:00 A.M. Those present were Kerry Regier, Chairman; Brad Raven, Vice-Chairman; C.J. Rose, Member; Scott Mitchell, Reuben Parker, Jr., and Lisa Bennett, County Clerk/Secretary.

Motion was made by Raven and seconded by Rose to approve the minutes of the December 26, 2017 meeting. Motion carried with voting; Regier, Aye; Raven, Aye and Rose, Aye.

Commissioners conducted the annual jail inspection.

Following discussion of the criteria, motion was made by Raven and seconded by Rose to approve a Beaver County Burn Ban. Said ban will remain in effect for fourteen (14) days from this date, at which time conditions will be reviewed, causing the Burn Ban to be removed or renewed.
