The items listed herein are to be used as a guide for the Bidders agreement to sell, and shall not be considered as the County's agreement to buy. However, it is anticipated that the County will buy the majority of the items listed within the time specified. **All items shall be in compliance with the required Oklahoma State Department of Transportation and Federal materials specifications.****

4. Firm prices will be F.O.B. destination.
5. Purchases by Beaver County, Oklahoma, are not subject to state or federal taxes.
6. This bid is submitted as a legal offer and any bid when accepted by the County constitutes a firm contract.
