# **Balko Fire Department 5 Ton Brush Pumper Spec Sheet**

Truck and apparatus will be based on a 900 series 6x6 military truck. Specs are for the fabrication of a custom apparatus and various items so vehicle is functional to fight wildland fires.

## **Components**

Truck - 900 Series military 6x6 with a turbocharged engine, 5 speed auto transmission, and super single tires.

Cab and Chassis - Various items will be welded and fabricated as needed to make vehicle functional for fire suppression and user friendliness. Grill guard will be added to front of truck for radiator protection.

Paint and Decals - Cab will be painted red, bed will be black, and all decals will be printed on reflective material. Decals will be provided by BFD.

Tool Storage - 8 ft tool boxes will be mounted to both sides of truck bed for tool storage.

Bed - All heavy equipment will be mounted with Grade 8 bolts or welded chocks or both. Walkway and ladders and gates will be fabricated as needed for fire fighter safety and convenience.

Tank - 1000-gallon poly agriculture style tank.

Hose Reel - 1 inch, 100 foot, with selectable gallonage nozzle, mounted per specs.

Pump - 170gpm @ 150psi to 250gpm @ 100psi, mounted under bed with 15+ gallon fuel tank mounted as near as possible. (Hale HPX200-B18 equivalent)

Control panel - Mounted and equipped inside truck cab.

Plumbing - Schedule 80 fittings, brass valves, high pressure red line hoses, T bolt style hose clamps, all pressure and vibration tested.

Whip lines - Dual 1-inch lines at the front of truck bed, outfitted with selectable gallonage and smooth bore nozzles.

Monitor - 12-volt Forestry monitor with joystick control. Selectable gallonage nozzle - 30,60,95,120 gpm options. (Akron equivalent)  
Monitor will be provided by BFD.

## **Lighting**

Truck - All original DOT lights will remain on truck. Headlights will be upgraded to LED's.

Emergency - Two 7x9 flashers in truck grill, five surface mount flashers on both driver and passenger sides, four on rear of bed, and eight on top of truck cab.

Lights and siren controls - Siren control will be quality brand with a 100-watt speaker, and main light control will be capable of controlling all emergency lights on apparatus.

Auto charge - A battery maintainer system and a shore air connection will be installed and wired/plumbed to truck.

Accessory items - All tools, lights, and various equipment will be mounted in tool boxes, or in truck cab as requested by BFD.
