SPECIFICATIONS AND INSTRUCTIONS TO BIDDERS

All bids must be filed with the County Clerk, no later than 5:00 p.m. on March 20, 2026. Bids will be opened on March 23, 2026 at 9:30 a.m.

Bids must be received in **sealed envelopes with "6 mo. bid #____" and closing date** written on the **outside** of the envelope. The bid # can be found at the top of your bid sheet and is listed below.

Please clearly mark the outermost envelope with your bid number so that it is not inadvertently unsealed prior to bid opening.

2. Late bids will not be considered. Bids must be received in sealed envelopes (one to an envelope) with bid number and closing date written on the outside of the envelope.
3. Unit prices will be guaranteed correct by the bidder.
4. Firm prices will be F.O.B. destination.
5. Purchases by Beaver County, Oklahoma, are not subject to state or federal taxes.
6. This bid is submitted as a legal offer and any bid when accepted by the County constitutes a firm contract.
7. Oklahoma laws require each bidder submitting a bid to a county for goods or services to furnish a notarized sworn statement of non-collusion. A form is supplied below.
