The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on December 3, 2007. Notice of the meeting was posted for public information on November 29, 2007 at 4:00 p.m. at all three entrances to the Beaver County Courthouse and www.okcounties.org/beaver.

Raven called the meeting to order. Those present were Brad Raven, Chairman; C. J. Rose, Acting Member; Richard Cowan, Member; Karen Schell, County Clerk/Secretary, Dayla Pugh, Keith Shadden, Mechille Calhoun, Sharon Raven, Denise Janko, Reuben Parker, Sherri Merle with the State Auditor & Inspector's Office and Rodney Seawright, Architect.

Motion was made by Cowan and seconded by Rose to approve the minutes of the November 30, 2007 meeting. Motion carried with all members voting aye.

Motion was made by Cowan and seconded by Rose to approve the monthly report for the Court Clerk. Motion carried with all members voting aye.

10:00 County Officer meeting was held. Sherri Merle with the State Auditor presented the audit findings for 2006 & 2007. (A complete report is available in the County Clerk's office.) Mechille Calhoun said that they are printing the tax statements and hope to have them out by Christmas. Sharon Raven said everything is going good and they will not be having any jury trials for December. Denise Janko said they are having a bake sale at the Library as a fund raiser for Friends of the Library. She also said they would be drawing for the Christmas tree today. She said that there would be a Library board meeting on the 11th and will have three board positions to replace. Dayla Pugh said she was glad the tax rolls were delivered across the hall for the Treasurer's to begin their part. Karen Schell said their office was behind a month and flooded with landmen. Keith Shadden said the Turpin sirens are functioning again. George will be here to check the ones in Beaver. NIMS 300 training will be Dec. 4, 5, 6 and the NIMS 400 will be the third week in Guymon. Reuben Parker said they were trying to get things finished and get the jail emptied. He said they are still trying to get the phones in the visitation room installed and they need to get an intercom system. He said the cameras are not in yet and they are still working on the outside and hope to be done this week. Parker also said the assessment for the courthouse security was in for anyone that wants to look at it and he would like to have some input from the other officers about it. He has a \$26,000.00 grant and collects \$5.00 on every civil case for the security account. He would like to close off portions of the offices that collect money and is looking for an intercom system for the courthouse.

Rodney Seawright said he is not getting a lot of interest for the courthouse project. He has sent out 22 sets of drawings and doesn't know what he will have for the bid opening next week.
