Beaver County, Oklahoma County Commissioners Proceedings March 24, 2008

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on March 24, 2008. Notice of the meeting was posted for public information on March 20, 2008 at 4:00 p.m. at all three entrances to the Beaver County Courthouse and www.beaver.okcounties.org.

Raven called the meeting to order. Those present were Brad Raven, Chairman; C. J. Rose, Member; Richard Cowan, Member; and Karen Schell, County Clerk/Secretary.

Motion was made by Rose and seconded by Raven to approve the minutes of the March 17, 2008 meeting. Motion carried with all members voting aye.

Motion was made by Cowan and seconded by Raven to approve a raise effective 4/01/08 for Glen Raven to \$8.50 per hour as top pay for dispatcher. Motion carried with all members voting aye.

Motion was made by Rose and seconded by Cowan to approve a raise to 1st deputy salary of \$2,123.33 per month for completion of 6 months as Emergency Management Director. Motion carried with all members voting aye.

Motion was made by Rose and seconded by Raven to approve the monthly report for the Fair Board. Motion carried with all members voting aye.

Motion was made by Cowan and seconded by Rose to approve an application for buried telephone facilities from PTCI between sections 9, 10, 15 & 16-3N-24ECM. Motion carried with all members voting aye.

Motion was made by Cowan and seconded by Rose to approve an application for buried telephone facilities from PTCI between sections 22, 23, 26 & 27-6N-20ECM. Motion carried with all members voting aye.

Pursuant to Title 62 § 335 a reimbursement was made to the Fair 84D account for \$50.00 for polling place rental.

Motion was made by Rose and seconded by Raven to approve the Cash Fund Estimate of Needs and Request for Appropriations for the following accounts. Motion carried with all members voting aye.

Raven and Rose both oppose the overtime pay due to the fact it goes against county policy. Rose asked if Cowan had advertised for help and Cowan stated that he did a year ago. Rose said that he would be glad to send a few of his employees over to help get caught up with their work and maybe he could borrow the Dist. #3 hot oil truck for a swap. Cowan said he would not loan the truck. Rose said he would still send the employees if Cowan wanted to pay them.
