Beaver County, Oklahoma County Commissioners Proceedings March 7, 2011

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on March 7, 2011. Notice of the meeting was posted for public information on March 3, 2011 at 4:00 p.m. at the East entrance to the Beaver County Courthouse and www.beaver.okcounties.org.

Rose called the meeting to order. Those present were C. J. Rose, Chairman; Brad Raven, Member; Frank King, Member; Mike Boring, DA, Dana Hibbs, Blaine Beckley, Adam Epp, Kay Epp, Robert Hutton, Linda G. Wolf Brown, Robert F. Brown Jr., Angel Ortiz Gonzalez, David Glascock and Tammy Millikan, County Clerk/Secretary.

Motion was made by King and seconded by Rose to approve the minutes of the February 28, 2011 meeting. Motion carried with all members voting aye.

Motion was made by King and seconded by Rose to approve the following requests for purchase orders from General Government Sales Tax Account 66F. Motion carried with all members voting aye.

Assessor – Stanfield Printing Co. for supplies in the amount of \$128.96 Sheriff – G & G Electronics for repairs in the amount of \$400.00

Motion was made by Raven and seconded by King to approve the appointment of Kelly Yeomans as 1st Deputy County Clerk effective March 1, 2011. Motion carried with all members voting aye.

9:30 - Robert Hutton, Dana Hibbs, Blaine Beckley, Adam Epp, Kay Epp, Linda G. Wolf Brown, Robert F. Brown Jr. and Angel Ortiz Gonzalez met with the Board to discuss concerns they have for neighboring property to their homes, located in the SE/4 of Section 22-6N-20ECM. Hutton presented pictures, which are not only unsightly, but which they also feel present safety hazards & EPA concerns. Old appliances, tanks, mobile homes and vehicles are accumulating and the group would like the assistance of the Board in correcting the issue. Mike Boring, DA, recommended they contact the Dept. of Environmental Quality in Guymon and ask for an inspection of the area of concern. Boring suggested a map of the area with details of concerns to be presented to the DEQ, who may be of assistance any time there is a potential environmental hazard violation. Boring explained that without zoning codes, which very few counties have at this time, or findings from the DEQ, the only other option would be court proceedings. Hutton asked if this could be considered a nuisance in court proceedings and Boring replied that it could be, but this is sometimes very difficult to prove since property owners can use their property to their likings. Vehicles placed in what is known as the "wetlands" was discussed with the Board & Boring suggesting that the Dept. of Wildlife or Soil Conservation District could be helpful in this area. A letter from Turpin Fire Chief, Gary Riffe, who was unable to attend the meeting, was also presented to the Board. Riffe's letter expressed the same concerns as the others in addition to the fire hazard and obstacles presented to the fire department if they have to combat a fire in the vicinity. Boring stated that with the help of the County Clerk's Office, he would do some research to see if deeds were being issued for small parcels, which should meet platting requirements. The Board assured the group they would do anything they can legally do to assist them in this situation and would be checking on any options which they may have. The group thanked the Board for their support and expressed that they would be in touch with the DEQ before continuing with other options.

David Glascock met with the Board asking if there would be any financial assistance available for the burial of Judy Brennon, a citizen of our community. The Board advised Glascock that they would like to help and will check to see what they can legally do and let him know.
