Beaver County, Oklahoma County Commissioners Proceedings March 21, 2016

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on March 21, 2016. Notice of the meeting was posted for public information on March 17, 2016 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse as well as www.beaver.okcounties.org.

Raven called the meeting to order. Those present were Brad Raven, Chairman; Frank King, Vice-Chairman; C. J. Rose, Member; Abby Cash, Ryan Jett, Karl Jett, Ramona Jett, Rachael Jett, Rich Henkel, Landon Nine, Charlie Starbuck, Pauline Heinz, J.C. Dunigan, Dusty Sperry, Curtis Parker, Alissa Schlessman, Reuben Parker, Jr., Shawn Stoddard, David Glascock, Nick Koehn, Tanya Koehn, Gary Riffe and Tammy Millikan, County Clerk/Secretary.

Motion was made by Rose and seconded by King to approve the minutes of the March 14, 2016 meeting. Motion carried with voting; King, Aye and Rose, Aye. Raven abstained from the vote due to being absent from said meeting.

Discussion was held regarding a possible County wide burn ban, which was tabled from the March 14, 2016 meeting. Motion was made by Raven and seconded by King to take no action at this time with an evaluation made each week until there is a need to implement a ban or there is no longer a need. Motion carried with voting; Raven, Aye; King, Aye and Rose, Aye.

Motion was made by Raven and seconded by King to approve a Lease Purchase Agreement, tabled from the March 14, 2016 meeting, by and between Board of Beaver County Commissioners and Oklahoma Dept. of Transportation for a 2017 Armor Lite Belly Dump Trailer, for Dist. #1. Motion carried with voting; Raven, Aye; King, Aye and Rose, Aye.

10:00 ~ Concerned citizens and various EMS professionals met with the Board for discussion regarding ambulance service in the Slapout Community, with the possibility of an ambulance being stationed at the Slapout Fire Dept. David Glascock, Beaver County EMS Director, informed the Board that there is currently an ambulance which could be made available immediately in said area and there are four highly qualified Emergency Medical Technicians from the Slapout Community.

Rich Henkel, Director of Education, for the private entity EMERG (Emergency Medical Education and Resource Group, Inc.) expressed a desire for his company to provide ambulance service in the Slapout Community and answered various questions which were asked by the Board.

Shawn Stoddard, a representative of the Buffalo EMS and Pauline Heinz and J.C. Dunigan, representing Laverne EMS were also in attendance explaining the system in which they work with Beaver County EMS through a mutual agreement.

Reuben Parker, Jr., Beaver County Sheriff; Alissa Schlessman, Beaver County Memorial Hospital Administrator and Charlie Starbuck, Slapout Fire Chief were also in attendance to address various concerns and effects of whether this service would be provided by Beaver County EMS or a private entity.

Abby Cash, Assistant Dist. Attorney, was in attendance to hear all related discussion, in order to advise the Board, as their legal counsel.

Upon completion of discussion, motion was made by Rose and seconded by King to take no action at this time. The Board would like to attend the next meetings of the Beaver County Hospital Board and Beaver County EMS Board, both of which are appointed by the Board of County Commissioners, for discussion regarding the matter. In addition, the Board will seek further counsel from the District Attorney and will continue further discussion and possible action in the April 25, 2016 meeting at 10:00 A.M. Motion carried with voting; Raven, Aye; King, Aye and Rose, Aye.
