Beaver County, Oklahoma County Commissioners Proceedings November 28, 2016

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on November 28, 2016. Notice of the meeting was posted for public information on November 22, 2016 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse and www.beaver.okcounties.org.

Rose called the meeting to order. Those present were C. J. Rose, Chairman; Brad Raven, Vice-Chairman; Frank King, Member and Tammy Millikan, County Clerk/Secretary.

Motion was made by Raven and seconded by Rose to approve the minutes of the November 21, 2016 meeting. Motion carried with voting; Rose, Aye; Raven, Aye and King, Aye.

Motion was made by Rose and seconded by King to approve an Application for Road Crossing from Rodney Meyer between Sections 14 & 23-2N-22ECM. Motion carried with voting; Rose, Aye; Raven, Aye and King, Aye.

Motion was made by King and seconded by Rose to approve the Revised FY17 Resolution Approving Interlocal Cooperative Agreement for Circuit Engineering District. Motion carried with voting; Rose, Aye; Raven, Aye and King, Aye.

Motion was made by Raven and seconded by King to approve the request to hire Lisa Bennett as part time deputy County Clerk effective December 1, 2016. Bennett's hourly wage of \$10.00, and any benefits, will be paid from County Clerk Account #Cash-10B. Motion carried with voting; Rose, Aye; Raven, Aye and King, Aye.

Motion was made by Raven and seconded by Rose to approve an Agreement between the Board of County Commissioners and Signtronix on behalf of the Beaver County Free Fair, for a lighted sign to be provided to the Free Fair at the cost of \$14,150.00. Said purchase was approved at the November 1, 2016 Fair Board meeting, whereas OSU Extension agreed to provide and reimburse the Free Fair for one half of the cost. Upon execution of the Contract, a 20% down payment will be paid, with the balance being paid upon delivery of the sign. Motion carried with voting; Rose, Aye; Raven, Aye and King, Aye.

The Board reviewed the Executive Proclamation received from Governor Mary Fallin, calling for a Special Election to be held to fill the vacancy in the office of County Commissioner Dist. #3, due to the retirement of Frank King, effective December 31, 2016. The Proclamation calls for a filing period for the Special Election beginning December 5, 2016 and ending December 7, 2016. A Special Primary Election shall be held on February 14, 2017 with the Special General Election on April 4, 2017.

The Board reviewed the 2016/2017 ACCO-SIG Property Coverage Agreement and Liability Coverage Agreement.
