They have a potential building in place and have been in touch with the Burn Association for possible donation of Fire Truck. They have numerous volunteers and will provide training. There goal is to control/manage wildfires until additional help can arrive. The Commissioners were all in agreement that this would be beneficial to that area and the County. Kyle and Loren will follow up and keep The Commissioners informed of the progress.
