The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on September 7, 2021. Regier called the meeting to order at 9:00 A.M. Those presents were Kerry Regier, Chairman; C. J. Rose, Vice-Chairman; Roy Fleming, Member, Reuben Parker, Scott Mitchell, Kyle Barby, David Britton, Keith Shadden and Kelly Yeomans, County Clerk/Secretary.

1030 ~ Kyle Barby addressed the Board requesting sponsorship from the County if he applies for an OEDA REAP Grant. He would like to apply for a grant to drill a water well or possibly use an existing well to be used for a bulk water station. This could benefit the Fire Departments, County Trucks and Farmers in the event bulk water is needed. Rose stated it would need to be on county owned land. Kyle also addressed the Board regarding mutual aid and being dispatched out in the event of a fire. Regier relayed since Clearlake FD is a private Fire Department and not a County Fire Department, they do not fall under the county dispatching protocol. They can be called via telephone if additional assistance is needed. Regier has visited with our DA and since they are a private fire department there are more liability issues. It was suggested Barby seek legal advice and Regier will get more legal advice and information as well from our DA. No action was taken and will be tabled until next week after further information is obtained.
