

Beaver County, Oklahoma
County Commissioners Proceedings
April 12, 2021

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on April 12, 2021. Notice of the meeting was posted for public information on April 08, 2021 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse and www.beaver.okcounties.org.

Regier called the meeting to order at 9:00 a.m. Those present were Kerry Regier, Chairman; C.J. Rose, Vice-Chairman; Roy Fleming, Member, Scott Mitchell, David Glascock, David Jett, Kyle Barby, Tammie Patzkowsky, Lesa Slatten, Albert Rodriguez, Denise Janko, Christi Lansden, Keith Shadden, Liz McBee and Kelly Yeomans, County Clerk/Secretary.

Motion was made by Regier and seconded by Rose to approve the minutes of the April 05, 2021 meeting. Motion carried with voting; Rose, Aye; Fleming, Aye and Regier, Aye.

Public Comment: David Jett spoke briefly to the Commissioners regarding re-claiming our rights. He voiced his concerns over several matters regarding citizens' rights and what is going on in the Nation at this time. He would like to see a county wide proclamation implemented by the County to protect our rights. No action taken by the Commissioners.

Public Comment: Kyle Barby spoke with the Commissioners regarding the Clearlake Fire Department. They recently received a grant from OEDA and purchased a fire truck. Gear has been installed and ready for inspection and completion of the grant. The grant was managed by Beaver County. The issue with liability has been a concern with the Commissioners since they are not a sales tax entity of Beaver County. The question on paging Clearlake out on calls is another concern. Kyle stated they will have all of their firemen insured. Regier is waiting on more information from the Forestry Department regarding all issues. No action taken by the Commissioners.

10:00 ~ Officer/Department Head Meeting ~ Regier stated "As requested by our State Auditor's Office, the Board would like to ask all Officers and Department Heads, if you are aware of any suspicious or fraudulent activity regarding County Employees." None were reported. Each office reported on activities affecting their office. Shadden is busy working on grants and getting prepared for storm season and fires. Lansden reported they just completed school elections. Rodriguez reported that 2nd half of tax statements are completed and Notice for Resale for delinquent taxes have been sent. He also informed the Board that KellPro will no longer be supporting the Treasurer software. A conversion will be done sometime soon and will be converting to the Tom Martin version. McBee reported various programs and activities that are going on. Beaver County was well represented at the District 4-H contest in Woodward. They are hoping the Summer Workshops can be in person this year for the kids. Janko has been busy applying for grants, children's weekly programs and adult exercise classes. She is getting prepared for the Summer Reading Program. Slatten reported they are busy with routine office duties and training of new employee for the field. Patzkowsky reported normal office duties and are hoping to get new countertops installed in the next few weeks then they can proceed with the glass partition. Yeomans stated they are beginning to get things ready for the new fiscal year including preparation of the budget. Mitchell reported PTCI is testing connectivity for the new Dispatch/911 call station. They hope to go live around the week of April 28th. Rose, Fleming, and Regier all reported grading, rock hauling, mowing and general road maintenance. Several highway employees will be retiring within the year that have dedicated many years of service to Beaver County. We appreciate their service and wish them a happy retirement.

Motion was made by Regier and seconded by Rose to approve the IT Services Agreement between Beaver County Assessor, OSU (CLGT) and AF3 Technical Solutions, LLC to provide Server Services and Preventative Maintenance on a monthly basis at no fee charged to the County unless they come on sight after hours, week-ends or holidays. Equipment/hardware will be charged with 25% off purchases. Agreement effective date is March, 01, 2021 and either party may terminate by giving not less than a 60-day notice. Motion carried with voting; Fleming, Aye; Rose, Aye and Regier, Aye.

Motion was made by Regier and seconded by Fleming to approve the Detention Services Agreement between The Board of County Commissioners for Tulsa County on behalf of the Tulsa County Detention Center and The Board of County Commissioners for Beaver County, pending ADA approval. Juvenile Detention Services will be \$68.25 per day. Agreement effective dates are July 01, 2021 through June 30, 2022. Motion carried with voting; Rose; Aye, Fleming, Aye and Regier, Aye.

Motion was made by Regier and seconded by Rose to approve a PO over \$2,500.00 for Forgan Fire Dept. to TNT Hydraulic for Repairs to Fire Truck. PO #2873 was made in the amount of \$2,500.00. Motion carried with voting; Rose, Aye; Regier, Aye and Fleming, Aye.
