The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on December 13, 2021. Notice of the meeting was posted for public information on December 9, 2021 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse and www.beaver.okcounties.org.

Regier called the meeting to order at 9:00 a.m. Those presents were Kerry Regier, Chairman; C.J. Each officer/department head reported on activities in their department. Lansden reported they are waiting on new maps for the redistricting. School Board election will be held in April. Slatten reported they are busy with daily duties and her first deputy is finishing up with required schooling and her second deputy will begin working on hers. Rodriguez reported they have been busy with tax season and daily duties. They are preparing for a new Treasurer program to be installed soon. Parker reported the sheriff's office has been busy and theft is rising. Copper is one of the top item's thieves are after. Janko reported the library has been busy with the holiday season and Christmas on Douglas. They were able to raise around \$1,300.00 from their bake sale fundraiser through their Friends of the Library. Next summer's theme for Summer Reading will be Oceans & Sea Life. McBee reported they have 99 kids in 4-H and are very happy about this number of kids participating. Some of the club was going to the nursing home to decorate doors for the residents. Mitchell reported the 911 system is up and running. They have applied for an ongoing sustainable grant and they are still issuing out 911 signs.
