The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on June 21, 2021. Notice of the meeting was posted for public information on June 17, 2021 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse and www.beaver.okcounties.org.

Regier called the meeting to order at 9:00 a.m. Those presents were Kerry Regier, Chairman; C.J. Rose, Vice-Chairman; Roy Fleming, Member, Rueben Parker, Scott Mitchell, Darius Looper, Eric Depperschmidt and Kelly Yeomans, County Clerk/Secretary.

PUBLIC COMMENT: Eric Depperschmidt, Executive Director of Panhandle Regional Economic Development Coalition, Inc. gave a brief description of what they do and how they can assist the community. PREDCI is a non-profit economic development organization. Their purpose is to promote industrial and economic development, including jobs for the Oklahoma Panhandle region, Texas Panhandle and Southwest Kansas.

Motion was made by Regier and seconded by Rose to approve the FY22 IT Services Agreement between Beaver County Assessor, OSU (CLGT) and AF3 Technical Solutions, LLC to provide Server Services and Preventative Maintenance on a monthly basis at no fee charged to the County unless they come on sight after hours, week-ends or holidays. Agreement shall be for one year beginning July 1, 2021 and ending June 30, 2022. Motion carried with voting; Fleming, Aye; Regier, Aye and Rose, Aye.
