County Commissioners Proceedings  
December 30, 2024

The Board of County Commissioners met in regular session at 9:00 a.m. in the Office of the County Commissioners on December 30, 2024. Notice of the meeting was posted for public information on December 26, 2024 at 4:00 p.m. at the East, West and North entrances to the Beaver County Courthouse and [www.beaver.okcounties.org](http://www.beaver.okcounties.org).

Regier called the meeting to order at 9:00 a.m. Those present were Kerry Regier, Chairman; C.J. Rose, Vice-Chairman; Roy Fleming, Member; Reuben Parker, Scott Mitchell and Kelly Yeomans, County Clerk/Secretary.


